DECLARATION OF INDEMNITY

I the here undersigned, agree to participate in the event organised by the _____
_____ (hereinafter referred to as the **club**) subject to the rules and regulations, terms and conditions of the same as may be issued from time to time. I declare and warrant the following:

- That I am over 18 years of age and of sound mind;
- I also declare today that I am not aware of any known medical condition which may affect my personal and complete ability to take part in this event;
- That I possess a valid driving licence which permits me to drive a motor vehicle in Malta, without restrictions or conditions, other than those applicable to all drivers licence holders in Malta;
- That I am fully aware of the risks to property and to persons including bodily harm, injury or death which my competing in the event may give rise to both myself as well as to third parties;
- That I am fully aware that the **club** is the organiser of the event and that it declines any responsibility for participants, spectators, sponsors, race officials or contractors;
- That I am fully aware that the **club** may reschedule, postpone, or cancel the event for any reason;
- It is expressly stated that this indemnity form and its contents are not applicable to the insurance company which insures the event;
- That I participate willingly in this event;
- That I and the person(s) travelling with me are aware of the risks, dangers and perils present in motor-sport activities;
- That the vehicle being entered into this event is in a road- worthy condition within the limitations of its year of manufacture and that it is licensed for use on a public road. (where-applicable);

In consideration of the acceptance of this entry and of my being permitted to take part in this event, in respect of any parts of the event not held on public adopted road, I agree to save harmless and keep indemnified the **club**, such person(s), body or organization(s), as may be authorized by the **club**, to promote or organize the event and their respective official(s), scrutineer(s), marshal(s), representative(s), guarantor(s), promoter(s), sponsor(s), owner(s) of private property on or upon which the event is held, etc., from and against all responsibilities, actions, claims, costs, expenses and demands in respect of death of or injury to or damage to the property of myself, my driver(s), passenger(s), mechanic(s), and/or associated personnel, arising out of or in conjunction with this entry of my taking part in this event.
