### **NOTES ON SUBMISSION OF ORGANISING PERMIT APPLICATION**

#### **ORGANISING PERMIT APPLICATIONS**

Applications for events should be forwarded to the Secretary, Malta Motorsport Federation directly for approval of regulations, appointment of Stewards and issue of permit.

#### **DURATION OF EVENT**

The duration of event should include date/times of documentation & scrutineering (if separate to the main Event) but does not cover track testing.

#### **ATTACHMENTS**

- Please ensure all applicable documents are attached to the application
- Supplementary regulations are compulsory for all National events and must be approved by the Malta Motorsport Federation prior to publication.
- Entry Forms must comply with the National Sporting Code.
- Safety Plan must be submitted for all events except.

#### **FEES AND CHARGES**

The deposit of €20.00 is required to be paid before the permit is issued.

#### **INSURANCE**

Event must comply and be covered by the joint Malta Motorsport Federation Insurance.

#### **TIME LIMITS FOR APPLICATIONS**

This application form must be submitted to the Malta Motorsport Federation at least 30 days prior to the commencement of the event. The Malta Motorsport Federation will reply to such application within 15 days.
